Payment and Practice Updates Group and Concurrent Therapy Calculation Changes in SNF Will it impact your program?

The new Patient Driven Payment Model (PDPM) in SNF settings will calculate minutes of therapy for group and concurrent therapy differently than under the current RUG-IV payment system. The table below outlines the differences in the two payment models which was presented in a webinar hosted by the APTA, the Academy of Geriatric Physical Therapy, and the Education Leadership Partnership. Individual (Example: Individual PT 2,000)	-1:1 therapy (No limit) Minutes counted at 100%	-1:1 therapy (No limit) Minutes counted at 100%
Concurrent (Example: Concurrent 600)	2 residents treated at the same time but performing different activities (No Limit) ½ of minutes counted towards total minutes	2 residents treated at the same time but performing different activities (Group and Concurrent combined not to exceed 25%) 100% of minutes counted towards total minutes
Group (Example: 1,000)	4 residents performing similar exercises (not to exceed 25%) ¼ of minutes counted toward total minutes	2-6 residents performing similar exercises (Group and Concurrent combined not to exceed 25%) % of minutes counted toward total minutes

Note to Clinical Educators:

If your program utilizes concurrent therapy charges frequency when a student and CI are both treating a patient at the same time (i.e. treating 2 patients at the same time, but performing different activities), you may want to consider alternative arrangements to allow students to demonstrate independence in patient care while maintaining compliance with the 25% limit on group and concurrent therapy services.

Diversity/Equity/Inclusion (DEI)

Multiple motions came before the House of Delegates this summer regarding diversity, equity, and inclusion (DEI) including RC 24-19: INCREASING PROFESSIONAL DIVERSITY, EQUITY, AND INCLUSION IN CLINICAL, EDUCATIONAL, AND RESEARCH SETTINGS: That the American Physical Therapy Association, in collaboration with stakeholders, identify and implement best-practice strategies to advance diversity, equity, and inclusion within the profession of physical therapy to include clinical, educational, and research settings to better meet the needs of society.

How is APTA getting involved?

- The APTA Strategic Plan includes making the APTA an inclusive organization that reflects the diversity of the society that the profession serves with multiple action items to promote diversity in our profession.
- APTA to collaborate with state chapters on DEI.

APTA Supports New Bill That Protects Manual CRT Devices From Bidding

House lawmakers re-introduce language that would exempt manual complex rehab wheelchairs from the competitive bid program and also protect accessories for those chairs.

Two lawmakers have re-launched legislation in the House that would permanently exempt manual complex rehab wheelchairs from competitive bidding.

The bill, H.R. 2293, would also stop Medicare from applying bidding-derived reimbursement rates to accessories for manual complex rehab chairs for 18 months. Representatives John Larson (D-Conn.) and Lee Zeldin (R-N.Y.) launched the Protecting Access to Complex Rehab Manual Wheelchairs Act, which re-introduces legislative language that originally debuted in 115th Congress, but lapsed when that Congress's term ended.

Concussion and Mild TBI Updates

Concussion Awareness and Education Act H.R. 280 of 2019

Despite the growing prevalence of concussions among student-athletes and military service members, there is no comprehensive system for acquiring accurate data on the incidence, treatment, and prevention of concussions.

The Concussion Awareness and Education Act, sponsored by Joyce Beatty (OH-D), would direct the Secretary of Health and Human Services (HHS) to conduct concussion research and establish program to identify, formulate, and disseminate recommendations for education, treatment, and prevention of concussion. Presently, the bill has 36 bipartisan co-sponsors and is awaiting further consideration in the House Committee on Energy and Commerce.
