The **vision** of the Academy of Neurologic Physical Therapy is: **All people with neurologic conditions living their best lives.**





What is your professional primary role?











Upon approval of the request a confirmation will be sent to the contact listed on the submission for payment. **Payment options include credit card or wire.** A 3% processing fee will be applied to credit card payments. **Applications will not be considered complete and space will not be assigned until payment is received.** The number of exhibit booths is limited. Plan to submit your request early. Exhibit forms and payments must be received on or before September 9, 2025.

RULES AND REGULATIONS

2025 Annual Conference Prospectus

The policies stated below constitute a bona fide part of the **Application & Contract for Exhibit Space**. The exhibits are intended for educational and informational purposes to improve physical therapy education, practice, and research. They should complement the meeting and sessions by enabling registrants to see, hear, examine, question, and evaluate the latest developments in equipment, supplies, and services relevant to physical therapy. All material/equipment should be timely and relevant to physical therapy and should contain no inaccurate or misleading information. FDA Market Clearance: No product, apparatus, instrument, device, or drug that is the subject of litigation pending before the US Food & Drug Administration (FDA) may be exhibited. All exhibitors for which FDA market clearance applies shall have documentation from the FDA on all products being displayed available at the booth. The documentation should state the model and regulatory class of those products that have been determined to be medical devices, as defined by the Federal Food, Drug, and Cosmetic Act, Section 201(h). All products to be exhibited at ANPT Annual Conference must be identified on the application/contract and must include FDA market clearance status.

Academy of Neurologic Physical Therapy (ANPT) reserves the right to render all interpretations and decisions should any questions arise, and to establish further regulations as may be deemed necessary to the general success and well-being of the conference. ANPT may restrict exhibit materials that detract from the general character of the exposition. This reservation includes a person's conduct, images, videos and anything of a character that may be objectionable to the exhibits as a whole. Exhibits should be presented in a manner that is consistent with the association's policies on sexual harassment and nondiscrimination. All matters and questions not covered in these policies are subject to the final judgment and decision of ANPT.

Acceptance of Application: Academy of Neurologic Physical Therapy (ANPT) reserves the right to reject any and all applications. ANPT may determine the eligibility of any product to be exhibited at the ANPT Annual Conference either before or after the proper execution of the contract. Sponsors payment is due within 30 days of the application acceptance. After September 9, 2025 changes or additions will be addressed as time permits.

Breaches of Contract: Breaches or infractions of an exhibitor's contractual obligations could affect the status of the company's future eligibility to sponsor or exhibit at future ANPT Conferences. Termination may become effective during the conference, at which time the exhibitor's booth will be removed. Expulsion of, or restrictions placed on, an sponsor or exhibitor may not give rise to a claim for any refund of other conference expenses.

Cancellation of Sponsorship/Exhibitor Agreement: A sponsor has until July 1, 2025 to cancel the agreement with ANPT with a \$250 administration fee withheld. After July 1, 2025 a sponsor may cancel the agreement but no refunds will be provided. An Exhibitor-Only has until July 24, 2025 to cancel the agreement with ANPT with a \$75 administration fee withheld. After July 24, 2025 an exhibitor may cancel the agreement but no refunds will be provided. If the sponsor or exhibitor fails to set up their booth before the start of the conference they will not be given the opportunity to exhibit at future conferences.

Cancellation of Conference: It is mutually agreed that in the event of the cancellation of the conference due to circumstances beyond ANPT control, including but not limited to labor disputes, fire, storms, riots, natural disasters, government actions, widespread medical or health emergency constituting an epidemic or pandemic or other cause(s) beyond ANPT control that would prevent its scheduled opening or continuance, then and there upon this agreement will be terminated, and ANPT, at its sole and exclusive discretion, shall determine an equitable basis for the refund of such portion of the sponsor and/or exhibit fees as is possible after due consideration promotions have already occurred.

ANPT Exhibit/Sponsor Policy Statement: The ANPT represents physical therapists & physical therapy assistants that promote health through movement and optimize quality of life through exercise, hands on care and patient education. As such, ANPT maintains the right to decline any exhibitor/sponsor/advertiser that does not align with ANPT and APTA legislative priorities and ethical principles. In particular, vendors must align with our stated policy goals regarding population health, patient choice and access, value-based care and practice as well as research and innovation.
